Playing field

In response to the poor ROSPA report and after consideration to ongoing maintenance costs, several of the parish councillors and parishioners generously gave time and effort to address the situation. The boarding (much of which was rotten) was removed. The soft fall was reused under the zip wire to save costs. Grasslok safety matting was laid under the Borneo and the matting under the swings was taken up and re-laid. The whole area then had turf applied and was diligently watered. It was a considerable task. Many thanks to all those who took part. Although the grassed area is now extended, the maintenance costs have been drastically reduced as the overall grass cutting costs have been halved. It is anticipated that the soft fall under the zip wire will require maintenance this year. Due

to the success of the upgrading already undertaken, consideration is being given to applying the same remedial work. A refund on Co-op vouchers could be used to part finance the upgrade.

Grass cutting

Tenders for 2016/17 were obtained. They were £1042, £1163 and £521.52. the lowest bid was submitted by WLDC and was accepted. It took some time for this bid to come through and cutting started a little later than anticipated. However, after the first cut, a good job has been done. A further reduction was sought by offering allotments on the reserve burial ground. No-one came forward to take up the offer.

The precept for 2016/17 was set at £2897.00 based on 2015/16 costs.

Wind farm
